In an effort to avoid any further issues with the City of Leon Valley and as a courtesy I am giving you notice that I will be attending the Protest Event being held at Leon Valley on the 21st of July. I will limit my time in the area to 10:30 a.m. till 1:30 p.m. and will only be at/near the City Hall/PD bldg-specifically,I will be along the front perimeter of the buildings El Verde Rd. and the sidewalk along the side facing Bandera Rd. If the Protesters depart this area I will not follow. The Event is scheduled to begin at 11 and run to 1-I gave myself an added 30 minutes to get there and depart on each end. I will park in the parking lot on El Verde Rd.

I plan to attend this event to seek redress from the Leon Valley City Government for my mistreatment by its Officials (namely you and your staff). I will also be covering the Event as Media for publication.

I may or may not go armed. I carry where I am legally permitted to do so. You may verify with ATF (Laredo Office is a good point of contact-Agent Perez or the Agent In Charge)that my carry is legal.

Anarchists? I guess you'll call me a Sovereign Citizen next?

Both would be wrong. I believe in our Government. And I believe we need LE to keep order. I back LE 100% and make no secret about it-I say so in many of my videos.

What I do not back is bad Cops or bad policing.

I am not the problem-you are. You (and others like you) have forgotten YOU WORK FOR US. Making punitive arrests because you don't like us, our politics or the fact we call you out when your wrong is part of why you are the problem. Bad Cops (and cops that misuse their power) get good cops killed. Far as I am concerned-you are a cop killer.

A lot of citizens from within Leon Valley see what's going on and are getting behind us. Many veterans have seen your abuses heaped upon us mere citizens and are disgusted. These aren't "outsiders" either. As you'll find out next city election-if not sooner. Cats out of the bag and you are all found out.

I've researched your bio and I just do not understand. How can you be this obtuse. Are you really this dumb-or is it just a put on??

Your comment about my fearing for my safety is laughable. I mean given the use of forces that have injured several unarmed peaceful "activists" already.

I was not created in a vacuum. Bad Cops created me. And I thrive off of them now. I am their karma-I am "the hot coals the Lord has placed upon their heads". I've been (falsely) arrested-jailed-harassed-have had my family harassed-faced two assassination attempts in the last 18 months and none have been able to stand. Two things have saved me-BodyCam footage and God's Grace.

That you would publicly utter such stupidity as appeared in this article really tells the whole story.

You still living in the 90s when you could control the narrative and whatever you said was believed without question.

Those days are gone. Cameras and social media have (and continue to) expose LE lies and corruption. So many people came to my channel as non believers and after seeing my videos realized just how out of control the bad cops are..and now they back and support me. Even within the LE community. Because people are tired of PDs that do biz like you and yours.

You think this is about money? Take note of the fact I have never dragged a PD that wronged me into court IF they followed up doing the right thing. Check with UTMB PD in Houston. Check with Missouri City PD. La Porte PD. Harris County Pct 4 Constables. The list runs on. These agencies recognized their Officers did wrong and took corrective action. You attack citizens-you steal their property in an effort to silence them-now you cry like you are the victim. That's laughable.

City is hoping to settle these suits. Just to show you how money (un)motivated I am-I will not consent to any settlement. We are going to trial. And I am going to encourage everyone else to decline to settle and go to trial. Leave it up to a Jury to decide. Tell the city they can thank you for us mere citizens laying out that course.

FYI-many of the Open Records requests your getting are from within the City not outside. Citizens within LV are becoming aware something fishy is going on at city hall.

And, make sure you have a good Criminal Defense Lawyers number close at hand-I'd use the SAPD Union guy myself.

FBI/Rangers & AG are not just looking at all of us. Your getting scrutiny as well.

Earl,

Your unwarranted fear for your life while interacting with our department or my investigators is unwarranted and overly theatrical. That said, it sounds like you are preferring to handle this through the court system. I was hoping to help you expedite the process, but that is your call. As for the sexual predator law in Leon Valley, you can't be anywhere near where one of the safety zones are located, which the police department falls within. That said, you can come here or anywhere there is a governmental interest, but you must first notify us that you are coming within the restricted area of the safety zone and we shall escort you into the area and out of the area. We will be back in contact once the warrant is signed and the camera is available for pick-up. Have a great weekend. Chief Salvaggio

Chief,

Again,due to concerns for my safety-I cannot enter any area where you preclude someone videoing our interactions. And,for your protection (and mine) videoing the opening of the card is good for both of us. It keeps everyone honest. I don't care which computer is used-so long as it's videoed. And so we are clear-I am not permitting seizure of the videos only allowing you to copy them. I know what's on the SD Card-there is nothing but a couple interviews about Complaint Forms (and showing that forms were provided to those that requested them)and (because I arrived after you arrested everyone) video of the Journalists and Activists already detained/arrested. None of this relates to "online threats". It is only "police activity" (covered via Turner v Driver etc). You needed a warrant BEFORE you took my camera-not after. But,given what I now know about LV I m sure you'll get a Judge to rubber stamp whatever you throw in front of them-as you did with Jack Millers stuff.

So,if your willing to allow someone in with a camera to document (again,for both our protection) the process of opening the SD Card-then that's fine. And,if your only copying the videos-not removing them-that's fine. Give me a time.

If it will not be permitted to video the process-then I ll leave it with the Lawyers and Courts.

I can prove (check with DHS or FUSION Center,I never bluff-if I say I have something-I have it) when my camera was running and recording and what was captured. So,if anything is erased-I can prove it.

As for your RSO restrictions-am I to understand you are telling me (LV has a law against) I cannot be at or near City Hall/PD without facing Arrest??

Earl,

I am sorry, but you may not dictate the process. If you would like to come in, we can do that, but the card will be taken out of your device and downloaded directly onto ours. Of course, this is after you sign the voluntary consent form allowing us to do so. If you are not amenable to doing same, we will continue on our path to obtaining the search warrant for your device, at which time all original video content (preferred by the Court) will be downloaded accordingly. Your call, just let me know what you want to do so that your team of lawyers can work with our team of lawyers instead. Also, I am still waiting for an acknowledgement of your understanding of the law restricting convicted sexual predators in Leon Valley. You said you were going to discuss that with your lawyer and get back with me. Do we have an understanding of your limitations in our City? Please advise, as I would hate to see you arrested for violating the law. Chief Salvaggio

Chief,

I will be in San Antonio on Monday to meet with another of my Lawyers (this one is handling my Border Patrol lawsuit-and you likely thought I was kidding about having a team of lawyers (7)).

I met with my Media Lawyer yesterday (amongst others) and he instructed me how to proceed so that we are both protected.

Keep in mind that when you seize the camera of a media person you are taking away their ability to earn a living-and what you seek is not on the camera,it's on the memory card for the camera. Livestreams are not stored on the cameras-they are online (public and can be copied without a warrant-hint hint). So no reason to grab those cameras either.

But I digress.

I can meet with you anytime after 1pm-I will bring my laptop and a camera person to record everything. This is for my safety and to document when I open the SD Card that all video are there and accounted for. You give me whatever storage device you wish me to copy videos to and I ll do so. Because of concerns for my safety-we need to do this in the parking lot or somewhere cameras will be permitted. I may also bring one of my Lawyers along.

Just to be clear-I m not looking for trouble with you. I m doing all I can to avoid problems with you. I did all I could to avoid the situation to start with. Hence I wore my Media ID and vocalized (repeatedly) that I would happily provide my video. I typically would've been less cooperative-given the situation.

Understand,the footage on my camera has monetary and evidentiary value. While the evidentiary value is stable-the monetary value goes down daily. City of Leon Valley is liable for my losses.

Let me know what time you want to meet up and I ll be there. Or,if conditions are unacceptable to you-alert me to such and we ll work it out on a different level.

You may also call me to set a time if you wish-I will not publish any number you call from. Be aware,all calls to my cell are recorded (I get a lot of death threats and have been shot at twice in the last 18 months).

Earl Worden,

I don't recognize any of the "news organizations" in your signature block. I have looked them up and still don't understand how the credentials of "PNAC", or "Photography is Not a Crime" is a legitimate news organization. As such, we could not verify any of your "news" credentials at that time, nor at this time. That said, like I explained previously, we are more than willing to allow you to open up the recording devices and voluntarily consent to us downloading the original footage in relation to the incidents in question. Please advise a date you will be available to do so and we will work out a time accordingly. Please be advised, as a convicted and registered sex offender you cannot be within 500 feet of our parks and multiple other recreational areas in Leon Valley. This includes within 500 feet of the nature area where you were contacted on Saturday, as well as the hike and bike trail behind the police station. As such, by law, you will have to notify us ahead of time of your presence and must stay away from all areas listed in the law regulating convicted sex offenders in the City of Leon Valley. Please acknowledge your understanding of the City Park and Recreational Area Safety Zone law and that you may not be within 500 feet of these areas without prior approval. I will be your point of contact for that approval and to set up that appointment. I hope to see you soon. In your service, Chief Salvaggio

Chief,

I regret we meet under such circumstances.

I came upon your mass arrest/detainment Saturday. You had already grabbed up all the offenders and had them sitting around or removed to the interior of the station.

I am credentialed Media-in place to observe the protest that was underway. When I came upon the scene I remained a (very) respectful distance away (approx 200') and was documenting police activity. Credentialed or not-this is lawful,constitutionally protected activity. I ended up-at your direction-cuffed and taken inside the station. I was held for 90 minutes in cuffs. At no time when the Officer came at me did I resist. My media credentials were plainly visible on my chest. I told the officer and yourself I would be happy to provide you copies of my videos and I willingly IDd myself. Yet,I was held without cause simply because I witnessed you holding witnesses to a crime?

I m not sure where the logic lies in that. But more to the point-my gear (recording not live-streaming) was confiscated. I m not going to go into all the state and federal laws that prohibit this seizure here because it's pointless. I wanted to provide you with a chance to return my gear before I resort to getting my legal team involved.

FYI-taking cameras is not needed if you seek video evidence on them-you need the SD Cards that are in them. Taking cameras only resorts in shutting people down and preventing them from working. Unless that is your actual intent-to silence the voices of dissent?

But I m not here to pick a fight. Again,I just seek the return of my gear. As well as my assistants if possible.

I m easily reached by phone at [REDACTED] or by replying to this email.

Lastly,I think returning my gear-and possibly some others would go a long way towards calming this situation down. Let's work on some de escalation and dialogue. You might find that more effective than what your doing now.

Personally, I cannot imagine why you would have an issue with my gathering video evidence as to what is contained on the SD Card and not. Again, such a video would protect Leon Valley from a false claim that something was deleted when it was not. You only need fear the camera if you're doing wrong. Are you?

Concerns for my safety are real. And, given what I have heard on audio recordings from within your PD I believe those concerns are valid. Additionally, having testified against LEOs in the recent past and faced retaliation-I am always concerned for my safety.

Since you have RSOs living within Leon Valley I'm sure you have an Officer that handles the registration process. That Officer should have received proper training on where RSOs may be and where they may not.

"RSOs may not be prohibited or regulated from any Public Safety or Building where Governmental Operations (City Hall, Courthouse etc) occur by any policy or law. Or in the immediate area thereof."

I highly recommend you get with the AG about this and ensure city policy and laws are in line with this before you arrest anyone-especially me.

Additionally, if I participate in any 1st Amendment activities at/near the City Hall/PD you cannot preclude me from being there. Given previous input from the AG on this I will alert you that I am prepared to fight this in Court should you (falsely) Arrest me.

I do not want any more problems with you or the City. You guys have enough to deal with as it is.

But YOU WILL respect my rights.

I will do what I can to avoid conflict but don't expect me to lay down and lick your boots.

One last thing. You may verify with ATF that I have weapons that they have cleared me to possess. Additionally, I have a permit to carry them signed by the Governor himself. I have no ill will or intent toward any person-I carry strictly for self defense and in a minor that is legal. I am alerting you to this so there are no "misunderstandings". Please ensure all your staff is aware of this. I will be attending the "protest" planned for Leon Valley in July and I will likely carry during that event. I will be there to seek redress of my grievances with the city. In an effort to avoid problems with the city and possible arrest under your SO law-I will remain directly at/by the PD/City Hall. If it's your choice to arrest me at that time-then so be it.

You have people that back the blue. I'm one of them. I was 100% behind you after the Padilla incident-as was Jack Miller. You continue to turn people against not only Leon Valley but Officers everywhere due to your overly aggressive and questionable practices. Your ego is killing Leon Valley.

People that previously didn't back the freeway in place of Bandera Rd are now reaching out to TxDot urging them to move forward as quickly as possible. One has to wonder-what have you accomplished? Certainly not looking out for the citizens of Leon Valley. And everything that comes from this mess-YOU caused. It's unfortunate-one man's ego can destroy an entire city.

Bad cops get good cops hurt. You've got current and former LEOs lining up against you. Yet you continue rather than stop to evaluate things.

Makes me sad.

Please, call me David.

Thank you for making me aware of your city ordinances. I will verify with my Lawyer but (I believe) the area around the City Hall (PD) and/or Fire Station and Bandwrra Rd. are areas that City cannot preclude even RSOs from-especially if they are there for Constitutionally protected activities-or conducting biz. But I ll review this with my Attorney and possibly the AG to be certain. I seek to obey the law at all times.

Again, I think you have enough headaches to deal with-I don't want to be another of them. I just want my gear (and my assistants) returned so we can publish the footage captured. Also, I will make sure it's known you returned my gear so things will calm down abit.

I can provide you with points of contact to verify my credentials if need be-not that it matters as SCOTUS has determined that every citizen is independent media if they have an outlet-News Now Houston is seen worldwide via YouTube, as I m sure you know.

I told you and every Officer I had a chance to that I would happily provide my footage to you so all this could've been avoided.

It's obvious you ve seen the DHS Bulletin (and FUSION Center reports) on me so your aware I actually worked in Fed LE at one time. And that I frequently assist Federal LE. You ll think of me as a Police Antagonist because I don't blindly follow authority. I m not anti government or anti cop. I am anti bad government and anti bad cop.

Bad cops get good cops hurt-that's why I do what I do.

As I m sure your aware some documents and recordings from LV Gov and PD have been provided by an insider. What I have seen in those documents is bothersome. What I heard in the recordings is frightening. I do not have any of this evidence in my possession-they have been secured with a Lawyer in the SA area.

It's a shame (imho) you didn't stop with Padilla. You have him-100% guilty. Nobody backed what he did or how he acted.

Jack Miller was trying to do things right-and gets swatted for it.

I don't believe in beating a dead horse. Freeman/Boa and the others were wrapping up-at my behest-and prepping to depart. When you announced your "press conference" several Protestors and Media reps had to come back to be there for it. Had you just left it alone-it would've been over. I know posting the info on the chat was a LE ploy to give you the excuse to arrest activists. Nobody I know (including myself) condone such acts-nor do we condone acts of violence against anyone. Next group that comes will number in the hundreds-and be armed. I hope you will be more cautious then. I m trying to de escalate the situation-encouraging people to just let this play out in court. But, folks are pretty upset with what they ve seen. The "press conference" ploy was a bad idea-and a low blow.

And, frankly given what I heard in the recordings that were given to me-I am afraid of Officers from your PD becoming violent towards protestors. I have heard conversations where Officers speak openly about how they could shoot Freeman/Boa and get away with it. Sadly, some of these conversations (allegedly) involved management from LVPD. In any event-I will coordinate with you on the return of my gear. I am busy all day tommorrow with Civil Lawyers doing work on a case I have going in LA from my National Guard Arrest in Pineville. It will likely be next week before I can return to SA.

As I m seen as a leader in the police accountability movement (or a pain in the ass-depending on which side your on) I am fielding tons of calls from media and lawyers. Olmos Park was bad-this is far worse. Just to give you an idea how the public is seeing you and the PD.

If you have any questions or come up with anything I can help you with-feel free to Hollar at me. Nobody else needs be charged with a bogus crime. And nobody need be physically harmed or threatened. I would gladly do all I can to avoid these things-for both sides.

Earl Worden,

I don't recognize any of the "news organizations" in your signature block. I have looked them up and still don't understand how the credentials of "PNAC", or "Photography is Not a Crime" is a legitimate news organization. As such, we could not verify any of your "news" credentials at that time, nor at this time. That said, like I explained previously, we are more than willing to allow you to open up the recording devices and voluntarily consent to us downloading the original footage in relation to the incidents in question. Please advise a date you will be available to do so and we will work out a time accordingly. Please be advised, as a convicted and registered sex offender you cannot be within 500 feet of our parks and multiple other recreational areas in Leon Valley. This includes within 500 feet of the nature area where you were contacted on Saturday, as well as the hike and bike trail behind the police station. As such, by law, you will have to notify us ahead of time of your presence and must stay away from all areas listed in the law regulating convicted sex offenders in the City of Leon Valley. Please acknowledge your understanding of the City Park and Recreational Area Safety Zone law and that you may not be within 500 feet of these areas without prior approval. I will be your point of contact for that approval and to set up that appointment. I hope to see you soon. In your service, Chief Salvaggio

I regret we meet under such circumstances.

I came upon your mass arrest/detainment Saturday. You had already grabbed up all the offenders and had them sitting around or removed to the interior of the station.

I am credentialed Media-in place to observe the protest that was underway. When I came upon the scene I remained a (very) respectful distance away (approx 200') and was documenting police activity. Credentialed or not-this is lawful, constitutionally protected activity. I ended up-at your direction-cuffed and taken inside the station. I was held
