


Figure 2: Distance from the Speed Limit Sign to Intersection




Figure 3.1: Distance Intersection to Gate




Figure 4: Distance from crosswalk at Fry and Winrow to the first posted sign


Figure 5: Second Sign- LEOSA permits not authorized, gun restriction





Figure 10: Distance from Buffalo Gate to Van Deman Gate, where the no photography sign is posted
